## CAPITAL BUDGET ASK: INVEST \$50M IN THE EARLY LEARNING FACILITIES (ELF) FUND AND \$8.6M IN THE ELF PUBLIC SCHOOL DISTRICT PROGRAM

The ELF Fund makes high-quality, affordable preschool and child care available to more Washington families by preserving and expanding physical capacity to serve children.

Through ELF Fund programs, <u>Early</u> <u>Childhood Education and Assistance</u> <u>Program</u> (ECEAP) and/or <u>Working</u> <u>Connections Child Care</u> (WCCC) providers can access grants for pre-development, remodel, purchase, construction, and/or minor renovations of early learning facilities and classrooms. More learning space is a key component of working families having more access to early care and education. ELF Fund resources are distributed through three grant programs including:



- Eligible organizations grant
- Health and safety minor renovation grant
- Public school district grant

Since its inception in 2017, the ELF Fund has **retained and/or created a total of 17,676 early learning slots** and has leveraged \$274.4 million in non-state resources. Many of these resources have been prioritized for communities in greatest need, including:

- Rural counties and/or small cities and towns;
- Child care deserts (where the demand for care far outweighs the supply);
- Communities with low incomes
